

DEFIC Globe Inc. DATA OWNER APPLICATION FORM GENERAL APPLICATIONS

In the Law on Protection of Personal Data No.6698 ("KVK Law"), the personal data owners (hereinafter referred to as the "Applicant") have been granted the right to make certain requests regarding the processing of their personal data in Article 11 of the KVK Law.

Pursuant to the first paragraph of Article 13 of the KVK Law, the applications to be made to our data controller Company regarding these rights must be submitted in writing and by the following methods determined by the Personal Data Protection Board ("Board").

Within this framework, the applications to be made to our Company in "written" form, may be sent to us by printing this form; with the personal application of the applicant,

- Through a notary public,
- By registered mail
- It can be signed by the Applicant with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 and sent to the registered e-mail address of the Company.
